# President's Report



Five years on as President of Jewish Care. I would like to take this opportunity to reflect on our achievements and outline the key challenges Jewish Care faces in the future.

The merger of 2001 is fully bedded down and the benefits of creating a larger, more sophisticated single care entity have been realised. Jewish Care is now a leader in the provision of first-rate, quality care across the aged, disability and community sectors.

Jewish Care attracts over \$21 million of government funding for aged and disability services annually and last year we successfully grew our home-based services with an additional \$650,000 of funding. This clearly represents government's confidence in the work we do.

The community also demonstrates its confidence in our work by providing us with considerable funds every year to provide 'safety net' services for those in our community who struggle every day. Unfortunately, our community is not exempt from poverty, mental illness, homelessness, family violence, isolation and alienation.

This year we have seen an increase in demand for our emergency services as a result of the global financial crisis. However, I am delighted to report while other not-for-profit organisations have struggled, our community rose to the challenge, exceeding our Annual Appeal target by 10%. \$2.2 million was raised with the majority of our donors either matching or exceeding their previous donations. Thank you.

We are very proud of our magnificent new 120-room aged care facility, Gary Smorgon House, which was officially opened by the Hon. Justine Elliot MP, Federal Minister for Ageing, in July this year. While this is an important milestone, it is but the first step of the journey to transform and redevelop our aged residential services.

We face considerable challenges as our community is ageing at a faster rate than the rest of Victoria. At the same time, the largest portion of the Jewish community is concentrated in the City of Glen Eira, where availability and affordability of land is limited. Added to this is increasing evidence that baby boomers are not satisfied with traditional models of aged care and are seeking alternatives to taking up residence in nursing homes.

Jewish Care faces the challenge of providing new models of aged care that will be attractive to those who can afford to pay now and into the future. A financial turnaround in residential aged care is imperative for the sustainability of our organisation. It will enable us to continue to subsidise residential care for those without means and most importantly to preserve community funds for our vital support services.

The other significant challenge for Jewish Care is to assume a more active leadership role within our community. A well planned, strong and inclusive community can potentially improve the quality of life for all of its individual members. Jewish Care's approach has traditionally focused on responding to individual care needs. We will continue to do so, but this must be matched with equal attention to developing community-wide strategies, plans and partnerships to strengthen, mobilise and inspire the many organisations within our community to think and act collectively for the common good.

Two Board members are retiring this year. Andrew Schwartz, Vice President and Chair of the Board's Building Committee, has not only led our important redevelopments, he has also contributed significantly to all corporate matters. Andrew has been a wonderful support to me during my time as President and I wish to thank him for his expertise and commitment to Jewish Care.

David Brous, Chair of the Board's Service Delivery Committee, has served with the Board since 2002. David's extensive knowledge of all aspects of the public sector and government has been invaluable. I thank him for always striving to ensure the effectiveness of our many and varied care services.

Finally, I have decided to step down from the Presidency as I am confident that Jewish Care is now poised and ready to enter the next exciting stage of its evolution. Having worked closely with Bruce Rosengarten over these many months, I am impressed by his deep passion for the wellbeing of our community, as well as the calibre of his professionalism and vision. I welcome him as the incoming President and I look forward to working with him to ensure a smooth and effective transition. I wish him and all those involved in this magnificent organisation every success in the future.

# Chief Executive Officer's Report

More than 160 years have passed since our organisation first began to provide care and support for the needy members of the then fledgling Jewish community of Victoria.

As wave after wave of migrants established their home here, Jewish Care, together with the community, has continued to grow and to evolve, responding to the changing needs and aspirations of those it serves.

Our partnership with the Monash University Australian Centre for Jewish Civilisation has enabled us to develop accurate, reliable information about who we are and how our community is changing. The first Australia-wide analysis of its kind, the Jewish Population Survey 'Gen 08' has already begun to yield valuable information for community planning, not only for Jewish Care, but for all Jewish communal organisations in Australia as well as overseas.

More than 10 years ago, the Commonwealth Government's *Aged Care Act 1997* and new Australia-wide building accreditation standards, coupled with client and staff feedback, sparked a review of our aged care facilities.

The opening of Gary Smorgon House, our new aged care facility, this past year was a key milestone in realising our vision to bring to the Victorian Jewish community the latest in aged care accommodation. Gary Smorgon House incorporates intelligent engineering and stylish architecture while ensuring both functionality and design. Details such as central cabling for ease of maintenance, overhead hoists to accommodate our 'Ageing in Place' initiative, hydronic heating and Shabbat lifts are all reflective of careful planning which takes into consideration the needs of our residents well into the future.

Gary Smorgon House's smooth transition to full operation involved moving many of our residents from other facilities. I commend our wonderful staff for accomplishing this with a focus on meeting the needs of the individual. I congratulate them also for achieving the highest scores possible in four accreditation site reviews across all our facilities.

The subsequent closure of the Melbourne Hebrew Memorial Nursing Home (Fink Family Wing) in Ashwood marks a turning point as we embark upon this new era of aged care provision.

Another milestone achieved this past year was the foundation laying of the Glen Eira Road development for people with disabilities. Incorporating supported accommodation, community inclusion and independent living, this ground-breaking facility marks the culmination of a five-year collaborative process involving significant community consultation and engagement. The facility not only doubles the disability housing currently provided by Jewish Care, but is set to become a community hub for all people with disabilities through linkages with sporting associations, youth groups, shuls and local businesses.

Our partnerships with community organisations provide important avenues to advance common goals while at the same time leveraging off existing resources. This year has seen us strengthen partnerships with the Jewish Taskforce Against Family Violence, Access Inc., the Victorian Chapter of the National Council of Jewish Women, the Scout Association of Australia, ANZ, the Brotherhood of St Laurence, the new Jewish Inclusion Network, the Jewish Museum and others. We have embarked upon important research initiatives as well with major universities both in Australia and overseas: Deakin University, La Trobe University, Monash University, the University of Melbourne and the University of Kent in the UK.

The excellence of our work has won government endorsement. We have secured 13 new Community Aged Care Packages, 10 of which are directed towards the Eastern Metropolitan Region. The Commonwealth Department of Health and Ageing has provided further funding for our 'Stepping Out' program, our innovative centre-based respite option for older people. The Victorian Department of Human Services and its Southern Metropolitan Region have continued to support improvements and expansion of our disability service offerings.

To keep pace with the changing demands and in line with foreseeable shifts in the Jewish community's demographic makeup, our executive and senior management group undertook the development of a strategic plan which will provide a blueprint for the future direction and activities of our organisation over the next five years. Endorsed by the Board in June 2009, the Jewish Care Strategic Plan 2010–2015 will continue to pave the way forward.

I personally wish to thank the following departing senior staff members who have greatly contributed to our sustained growth over the past years and wish them well in their future endeavours: Colin Singh, Chief Financial Officer; Vanda Iaconese, Chief Operating Officer; and Kathy Devitt, Director of Residential Services.

I would also like to welcome Adam Goldberger, the newest member of our executive team, who took up the role of Chief Financial Officer in June 2009.

The achievements of the past year mark yet another stage in our organisation's ongoing journey in its mission to enhance the wellbeing of the Jewish community of Victoria. These achievements are a credit to the community that is Jewish Care: Board, managers, staff, volunteers, donors and, of course, our clients.

May we continue to go from strength to strength.

# **Community Support** Services

Together through the tough times

The Jewish community is not immune from the social and economic challenges confronting society at large. Over the past financial year our community has been impacted by the global economic crisis, placing unprecedented demand on Community Support Services. We are committed to ensuring that support is there when it is needed. We understand that for so many in our community, there is nowhere else to turn.

We start by listening. This year, we responded to a record number of calls for support and assistance. By providing objectivity and identifying key issues such as financial stress, unemployment or loss of accommodation, we have helped over 4,000 people in the community begin the process of moving forward.

This past financial year, we dispensed over \$100,000 of financial aid – nearly 7% more than in 2007–08 – and provided emotional and general support to 392 people through our counselling program. By continuing our partnership with orthodox counsellors, we have ensured greater access to professional support for religious members of our community. 2008–09 also saw the launch of the exciting Saver Plus initiative to assist lowincome families and individuals to save for their children's educational expenses while building long-term financial skills.

Our employment and training service, Always Moving Forward, continued to provide computer training courses and serviced a record number of jobseekers, with 56 successful job placements. In response to the demand for affordable emergency housing, we have established a Housing Taskforce and allocated a number of our Independent Living Units to augment our community's access to transitional accommodation. As in previous years, Jewish Care continued to provide vital assistance to holocaust survivors to complete the complex restitution application process.

By focusing on programs which enhance resilience and selfsufficiency, we helped individuals and families to get back on their feet. By providing long-term, enduring assistance, we ensured maximum benefit for both the individual and the organisation.

We have responded to the needs of our community under particularly difficult financial circumstances. Community Support Services receives little or no government funding, and therefore we rely heavily on donations to provide these vital services. Together with our community's support, we will help many more.

# Disability Services

Building an inclusive community for all

For many people with a disability and their families, life is a constant struggle to secure resources and support. A recent Commonwealth Government report presents a grim picture, indicating that many Australians with a disability are often isolated and alone. In Australia there are approximately 1,145,000 people with either a profound or serious disability, and in the Jewish community these figures are proportionally even higher.

This financial year, Jewish Care co-sponsored the launch of the Jewish Inclusion Network (JIN), a new community organisation which seeks to promote the inclusion of people with disabilities. Drawing on our successful partnership with Maccabi Victoria, we entered discussions with the Scout Association of Australia this year to start up a scout troop geared for children with disabilities. Once again, we exhibited artwork produced by members of our Mental Health Creative Art Therapy project at the Jewish Museum, providing an important opportunity for people with disabilities to build bridges with the community at large.

Through participation in research groups and partnerships with major local and international universities - Melbourne, Monash, continued to work at the highest Deakin, La Trobe and the University level, partnering with government of Kent (UK) – Jewish Care has continued to advocate for people with disabilities to enhance their quality of life.

In February, we marked the foundation laying of the Glen Eira Road development for people with disabilities, representing the culmination of a five-year collaborative community process. Our strategy of community-wide consultation and engagement has resulted in a facility concept which represents a ground-breaking vision of inclusiveness and a model for communities everywhere. Set to open in 2010, the Glen Eira Road development will nearly double the disability housing that Jewish Care currently provides.

The opening of our newly refurbished and relocated Children's Respite House in February this year reflects the importance of supporting our caregivers by providing culturally sensitive, quality respite options. The provision of respite facilities at the Glen Eira Road development will enable us to offer respite for caregivers of adults with disabilities as well.

Funding restrictions limit our ability to provide assistance to everyone who needs it. We have and key organisations, undertaking research, extending current infrastructure and developing initiatives to maximise existing resources.

Through community engagement, collaboration and leadership, we will continue to enhance and extend the opportunities available to people with disabilities.

# Community Aged Care

Nineteen per cent of the Jewish community is currently over the age of 65, as compared with the Victorian community, where the figure is 13%. Current trends indicate that more and more ageing members of the Jewish community wish to remain living independently in their own home for as long as possible.

We continue to pioneer new programs and models of service delivery which enable older members of our community to remain at home by staying healthy, active, connected and supported. During the financial year, Jewish Care was invited by the Victorian Department of Human Services to assist in the industry-wide development and implementation of the Active Service Model. This model seeks to keep older people as active and involved in daily living for as long as possible, including decision making about how they live their lives.

Our National Respite for Carers Program (NRCP), 'Stepping Out', was one of 12 programs across Australia chosen during 2008–09 for a site visit and evaluation. Our team presented at the Inaugural Victorian NRCP Services Network Best Practice Forum in May.

The Kesher case management service received a Rating One for Commonwealth Quality Reporting, setting quality standards for documentation and processes for large mainstream organisations as well as other culturally and linguistically diverse providers in the aged care field.


Our pioneering initiatives in recreational and therapeutic programming have become best practice industry models, as demonstrated by our 'Well for Life' exercise program, which we were contracted to run for Inner South Community Health Services.

In addition, we have continued to secure expanded recurrent government funding, including additional government-funded Care Packages and Claims Conference funding for holocaust survivors. This funding serves to assist people to maintain independence in their own home. During January, Jewish Care was successful in securing funding and commenced as a Designated HACC Assessment Service – the only ethno-specific service in Victoria and one of only two community service organisations to achieve this outstanding result.

With an ageing baby boomer generation set to dramatically shift our community make-up over the next 10 to 20 years, Jewish Care's commitment to communal planning and research reflects our investment in understanding, planning and meeting the needs of the Victorian Jewish community now and into the future.

# **Residential Aged Care**

We are committed to providing aged care services which accord all residents dignity and respect. We view residential aged care as an opportunity to enhance people's lives.

Our *heimish* environment provides opportunities for residents to participate in a wide-ranging cultural and spiritual program. Regardless of religious affiliation or level of observance, we believe everyone is entitled to their cultural heritage.

Our many volunteers help to support a vibrant recreational program and our staff are committed to developing meaningful activities that encourage residents to remain active and involved.

The opening of Gary Smorgon House in June 2009 marked a milestone for Jewish Care. This facility offers a level of comfort in an aged care environment never before available to members of the Jewish community of Victoria. Located on Freeman Street in the heart of Caulfield, the threelevel, 120-room facility offers magnificent communal spaces where residents can choose to meet with friends in the elegant café, relax in the lounge, enjoy a favourite movie in the theatre or share a meal with family in the spacious dining facilities. Our 'Ageing in Place' initiative means that residents continue to receive personalised care as their needs change, in most cases without having to change rooms.

Gary Smorgon House offers an attractive menu including traditional Jewish cuisine, prepared in a purpose-built Kosher kitchen. There is also a Rabbi on site to mark important Jewish events and a shul for Shabbat and festivals.

Gary Smorgon House heralds the beginning of a new era of residential aged care for the Jewish community. The decommissioning of the Melbourne Hebrew Memorial Nursing Home in Ashwood and closure of Kraus Nursing Home at St Kilda Road has set in motion a process to develop new facilities and expand choice in our residential care offerings.

# Development

Together for our community

Sustainable funding is vitally important to enable Jewish Care to provide its broad range of programs and services to the community.

Seventy per cent of Jewish Care's work attracts government funding, primarily in the areas of aged care and disability services. However, many of our programs and services are reliant on community support. Without this support, the viability of these programs would be jeopardised.

The goal of meeting Jewish Care's funding target for 2008–09 was undertaken in one of the most difficult financial years on record. By September 2008, businesses, trusts and private individuals were reeling from the impact of a global economic crisis. Charity funds were depleted and much of what remained was disbursed to the survivors of the devastating Victorian bushfires of February 2009.

In this climate, we went to the community to share our successes, and we need the community's challenges, achievements and goals, inviting new friends and old to share our vision of care and support. Our community welcomed meaningful opportunities to partner with Jewish Care, enabling us to implement a long-term, forward-thinking strategy based on engagement and relationship building.

Our Annual Appeal platform, 'Times are tough. Now is the time to give', challenged our community to help us meet Jewish Care's commitment to support families in need in our community.

In a year when many not-for-profit organisations, both in Australia and around the world, struggled to meet their budgetary demands, the Victorian Jewish community responded generously, exceeding our Annual Appeal target by 10% and raising nearly \$2.2 million. Of the more than 3,500 supporters who contributed to this year's campaign, the majority either matched or exceeded their previous appeal donation.

The financial crisis is far from over support to ensure long-term sustainability. With challenges still ahead. the Development team will continue to focus on our community's greatest asset: our people.

# Helping our young people achieve

Young Achievers is a mentoring and skills development program for young people aged between 15 and 18 years.

This past financial year, 32 young people participated in a range of workshops including Leadership and Team Building, Interview Skills and Public Relations.

# Taking a lead in wellbeing

As part of an initiative to tackle the issue of drugs and alcohol in the community, Jewish Care ran a number of sessions at Jewish schools, involving students in discussions and workshops addressing peer pressure, conflict resolution and healthy decision making.

# Inspiring our youth

The YouthInspire youth development and capacity building initiative was piloted from March to September 2008. Utilising social change as a springboard for youth leadership, the program provided an opportunity for young people to develop ideas to implement positive change in their local and global environment.

More than 300 dedicated volunteers donated over 23,000 hours of time this past financial year.

Their compassion, enthusiasm and commitment represents an invaluable contribution: they are the heart of Jewish Care.

Their vast skills and experience build our capacity to do good for more people in our community. Their daily expressions of kindness are invaluable to our organisation and the people we assist.

Our staff are supported by a vast network of dedicated volunteers. Our volunteers visit those who are lonely or isolated, offer guidance for our youth and initiate new ideas for development activities.

They assist special interest groups, host functions, run fundraising events, provide transport to outings - and they help to run our organisation. They are Board members, committee members, mentors and companions. They give of themselves generously and are passionate about what they do.

They are invaluable.







Jewish Care provides pastoral, Rabbinical, Kashrut and cultural services and support to clients, families, staff and volunteers. These are services which distinguish Jewish Care from other care providers. The Cultural and Spiritual Office is the custodian of the values and ethos which underpin our organisation and set Jewish Care apart.

# Appointment of Rabbi for Montefiore Shabbat services

Growing interest at Montefiore's Shabbat services has led to the commencement this year of a new Thursday morning prayer service at the St Kilda Road facility and the appointment of a Rabbi to help direct services on Shabbat and festivals.

# Training workshops for external providers

Representing Jewish Care's Cultural and Spiritual Office, Rabbi Meir Shlomo Kluwgant ran a series of workshops for a wide range of external care providers including Eastern Health and Glen Eira Council to help future care professionals understand Jewish attitudes towards highly sensitive ethical topics such as death, dying and other lifecycle issues.

# **Jewish Values** Committee

Membership on the committee has been expanded to include a diverse representation of views, backgrounds and attitudes on a wide range of topical issues facing the organisation.

# Engineering

Our Engineering Department maintains a safe environment, facilitating the optimal operation of all Jewish Care amenities and ensuring these remain compliant with mandatory guidelines and regulations.

# Watermapping

Over the past two years, in conjunction with local government and South East Water, Jewish Care has continued to review its water consumption, achieving a 45% reduction by implementing changes in procedures, hardware, maintenance and through the introduction of droughttolerant landscaping.

# Operations at Gary Smorgon House

The Engineering Department worked behind the scenes to ensure all services were in place to support the smooth transition to full operation of Gary Smorgon House and the decommissioning of the Melbourne Hebrew Memorial Nursing Home.

Jewish Care, supporting the community 24 hours a day, 7 days a week, 365 days a year.





# Human Resources

Our people are our greatest resource. Jewish Care recognises this by prioritising investment in ongoing staff training and development. Jewish Care's values of family, respect, charity, and kindness are integral to our organisation and provide a benchmark against which we measure interactions and the way we operate.

# Occupational Health & Safety

This financial year has seen the consolidation of the Human Resource team, which included a full-time occupational health and safety position and the introduction of an automated staff WorkCover claims management system.

# **Proactive Recruitment**

To raise the profile of Jewish Care as an employer of choice, Jewish Care partnered with a number of registered training organisations in 2008–09. These partnerships facilitate on-the-job training which leads to industry certification in a number of high-demand roles, such as personal care workers.

# Engagement Survey

During the financial year, Jewish Care ran the first organisation-wide staff survey. The survey produced a staff engagement score above industry standards of 77.8%.









# Staff Development

Culture, traditions and values are important components of our orientation, induction and ongoing staff training programs. This ensures that the particular needs of our clients are understood and that our services are delivered with sensitivity.

A crucial part of our staff development program is providing our staff with opportunities to learn new skills and to develop their existing skills including working towards certification in their area of operation. This includes providing development opportunities in areas as diverse as management, clinical care and occupational health and safety.

# Treasurer's Report

On behalf of the Chief Executive Officer and Board of Management, I am pleased to present a summary of the financial results of Jewish Care (Victoria) Inc for the 12-month period to 30 June 2009.

Jewish Care remains committed to continuous improvement in service delivery in order to maintain our high quality of care, while ensuring the organisation's financial sustainability – our greatest challenge.

# Strategic Planning

The following key deliverables of Jewish Care's strategic planning process were realised in the 2008 -09 year. The full financial benefits of these initiatives will be evident in the current financial year and beyond:

- The relocation from and decommissioning of the Melbourne Hebrew Memorial Nursing Home at Ashwood, resulting in an annual operating deficit reduction of \$0.8 million. This property is expected to be sold in the current year, with proceeds to be directed towards the capital development program.
- The opening of the new, state-of-the-art, 120-room aged care home, Gary Smorgon House. This efficient, contemporary facility is forecast to deliver an operating surplus once full occupancy is achieved.

A primary goal of the strategic plan is to review and upgrade Jewish Care's existing residential aged care building stock to meet current and future certification requirements, to reduce the residential services operating deficit and to apply the savings towards the overall group deficit.

# Summary of Key Financial Results

Jewish Care incurred a financial loss from ordinary activities of approximately \$6.712 million, as compared with \$5.925 million last financial year. Non-capitalised establishment costs for Gary Smorgon House and the cost of decommissioning the Melbourne Hebrew Memorial Nursing Home in Ashwood and Kraus Nursing Home on St Kilda Road contributed towards the increased deficit. The operating loss was incurred before the following items:

This resulted in a profit from operating recurring activities of \$1.998 million, as compared with \$2.323 million in the previous financial year.

The organisation has prepared financial statements in accordance with the Australian Equivalent of International Financial Reporting Standards (AIFRS) from 1 July 2005.

The Directors, in accordance with current accounting policies, have assessed the carrying value of land and buildings, which has resulted in a decrease of \$1.573 million, as compared with an increase of \$3.293 million last financial year.


