
THE HOLCKNER FAMILY PLEDGES \$5 MILLION

Two new building contracts were signed for The Anne & Eric Smorgon Active Living Centre in Caulfield and the 120-bed Senior Living Precinct in Carnegie. The Carnegie signing was followed by two ground-breaking events involving Board members and our supporters.

JEWISH CARE JOINS THE NATIONAL REDRESS SCHEME

Jewish Care became the first major provider of aged care, disability and community services to the Victorian Jewish community to join the National Redress Scheme. The scheme will offer redress to people who have experienced sexual abuse as a child in an institutional setting, and will include access to counselling, a redress payment and a direct personal response in the form of an apology from the responsible institution.

Jewish Care acknowledged and rewarded exceptional staff and volunteers for their valuable contributions at the 2018 Annual Staff and Volunteers Service and Excellence Awards. The major award, Samuel H. The four month campaign involved a range of activities including direct mail, newsletters, outdoor and press advertising, social media activities, Major Donor dinners, Tzedakah Sunday Telethon, and an Annual Appeal Dinner for 400 supporters.

GETTING JUDY'S LIFE BACK ON TRACK

Judy's first contact with Jewish Care was during her marriage breakdown. She was a mother of five children, struggling to deal with her own problems arising from a dark childhood. By this time, she had already left her five children and husband and living alone in a property belonging to her parents.

Despite her failed marriage and childhood flashbacks, Judy was also struggling with her mental health, living with anxiety and depression and experiencing family violence, including financial control and emotional abuse.

She also feared that her ex-husband was able to manipulate her and play on her vulnerabilities.

After a few discussions with Jewish Care's social worker, Judy, was able to trust the social worker into disclosing that she was once a victim of sexual abuse perpetrated by her own father. The social worker was able to engage Judy with numerous support groups such as South Eastern Centre Against Sexual Abuse and Newstart, helping her unlock years of horrible unspoken memories and experiences towards rebuilding her life.

Jewish Care was able to provide Judy with financial counselling, assistance to secure independent accommodation and access to employment services. She was also counselled into mending her relationship with her children, who were extremely hurt and heartbroken for walking out on them.

The social worker's tireless efforts and commitment to help Judy regain control over her life came to fruition when she received positive feedback from Judy. She also received a beautifully written poem and a hand-painted piece of art as gratitude for her support.

FEELING INDEPENDENT **AND FREE AGAIN**

Jared is a client of Jewish Care's Disability Services who has an NDIS Plan that assists him with support coordination.

As a result of his intellectual disabilities and physical limitations, Jared has been enduring many challenges from housing and employment to safety issues in his own home.

Jared's initial interaction with Jewish Care was when he contacted the Employment Centre, having being made redundant from his previous job.


The Employment Centre was able to provide career counselling and job seeking 'Tools and Techniques' training along with ongoing consultancy to determine suitable opportunities. And, the consultants continued to support him through his job seeking pursuit, even though he wasn't reaping any results.

Jared was then signed up with a disability employment provider where the Employment Centre was able to secure a wage subsidy for him. An opportunity finally came his way when he was offered a cleaning job with a cleaning company.

In collaboration with Jewish Care's Housing Support Team, Jared was also guided on how to manage his relationships with the current housing provider and others living in the same building, helping him to feel safe within his own home.

Jared is loving his new job and loves using the floor buffer whenever he is working. Most importantly, the employment consultants have noticed an improvement in his confidence and self-belief.

BRINGING GENERATIONS TOGETHER

The Mums and Bubs Play Group was reintroduced at Gary Smorgon House in the Memory Care Unit, in response to a request made by the Lifestyle team, to create a funfilled environment for Elders and toddlers to engage with one another.

Every month, children between the ages of two and five, turn up with their parents to engage in a variety of planned activities such as music, dancing, art, lunch, storytelling, or just visiting.

During the past several months, Elders were seen bonding with their regular visitors showing a bit of lightness in their faces as they sit and watch toddlers play or interact with them.

Since the launch of the first session in 2018, the play groups have become a favourite pastime of Elders, some liking to hold hands, stroke cheeks or listen to toddlers' babbling with a smile on their faces.

Most importantly, Elders have been able to socialise more often and renew their sense of self-worth, contributing towards improving their general wellbeing and health.

Tamara Zeltsman, Lifestyle Coordinator at Gary Smorgon House said, "It is beautiful and encouraging to witness so much excitement and joy in our Elder's faces and a positive change in their attitudes, impacting their overall health."

PRESIDENT'S MESSAGE

I am pleased to present my 2019 Report to our members, supporters, staff and community.

This is my seventh and final year as President of Jewish Care. I am proud of our progress over the past seven years. In my final President's Report, I want to highlight a few of Jewish Care's significant achievements.

The past seven years have seen major reforms in disability and aged care services. We can expect further change in the wake of Royal Commissions into these areas, as well as the Royal Commission looking at Victoria's mental health system. Jewish Care has not 'waited for' these reforms. Some years ago, we began exploring disability and aged care service models in Australia and overseas to determine what services have proven good outcomes. We have built on these at Jewish Care to deliver quality, contemporary services.

Our Disability Services have introduced person-centred supports, delivering services based on what each individual needs rather than taking a 'one size fits all' approach, and empowering clients to have choice and control over their lives. Rather than setting people with disability apart, we support them to increase their independence and participation in the community.

This approach means that our services and our staff need to be skilled and flexible. A good example of this is The Coppel & Piekarski Family Disability Respite Centre.

Opened in 2016, the Centre is a state-of-the-art facility offering programs for children and adults with a disability. While initially planned as an overnight respite centre, it now offers a range of programs reflecting the diverse needs and aspirations of people with a disability and their families.

In Aged Care, we are well advanced in establishing three best practice senior precincts. These precincts will provide contemporary, integrated, leading edge services and facilities for our community. The Hannah & Daryl Cohen Family Building, part of The Holckner Family Senior Living & Community Precinct, will be fully operational in the first part of 2020. Later next year, our new Carnegie Senior Living Community and the new Anne & Eric Smorgon Active Living Centre will open.

These facilities have been designed to support and enhance our Hand-in-Hand™ model of care, which will be introduced into all new residential homes from 2020. This model fosters a more caring environment for our Elders in smaller 'homes', where their involvement in the activities of daily life will be encouraged and supported. While our homes will be comfortable and contemporary, it is this new care approach that will transform Jewish Care into one of the aged-care leaders in this country.

These changes to facilities and services in disability and aged care are groundbreaking. They would not be

possible without the generous support of our community. We have now raised in excess of \$30 million for our Capital Campaign - an amazing result. I acknowledge the valued leadership of Patron of the Capital Campaign Committee Alan Schwartz AM, Co-Chairs of the Capital Campaign Committee Susie Ivany OAM and Lisa Kennett, and Mark Joel and his team.

We have also been well supported by the community for our Annual Appeal and other fundraising efforts. These funds enable us to deliver programs desperately needed in our community, which are unfunded or partially funded by government.

Jewish Care will continue to look to and rely on the community to support a range of services to meet our changing needs. An immediate challenge is to redevelop our social housing programs. Access to affordable housing is crucial for the one in five households in our community experiencing financial hardship. We have struggled to achieve financial support for this program. Expanding our social housing program will be a priority for the Jewish Care Board over the coming years.

In 2013, Jewish Care responded to the institutional abuse of children from predecessor organisations. Many Victorian organisations resisted accepting responsibility for abuse and have failed to provide redress to their victims. I am particularly proud that Jewish Care demonstrated strong moral leadership, quickly setting up a redress scheme when concerns were raised with our organisation. At the time, the Scheme was an exemplar for how organisations should support people who had suffered abuse at the hands of trusted adults and organisational leaders. Today, Jewish Care has joined the National Redress Scheme, providing care to victims of institutional abuse across the country.

We have had a strong focus on the culture of our organisation, shaping Jewish Care as an inclusive organisation committed to supporting all staff and all members of our diverse community.

In recent years, we have adopted important position statements related to Gender Equity and Equality, Asylum Seekers and Refugees, Safeguarding Children, LGBTI+ Inclusion, Family Violence and People Living with Disability. These statements ensure our practice is contemporary, inclusive and meets the needs of our broad community. Most importantly, these policies are a public statement of our organisation's values; they express what we stand for and what our staff, Elders, clients and community can expect of us.

In 2016, with an eye to the future and with the support of a few communal donors, Jewish Care established the Yesod Board Foundation Program. Participants in the program are taught to understand the professional duties



and responsibilities of not-for-profit board directors. Mentoring and supporting future leaders is vital to the growth and sustainability of Jewish Care and our community.

The strength of our partnerships is key to our progress. Our Board, CEO, staff, volunteers, donors, supporters and broader community have strong partnerships built on shared values and goals.

A most significant partnership for me has been with our CEO Bill Appleby. We have worked closely for seven years. I have appreciated his skill and diligence, his vision, commitment and compassion. We are lucky to have Bill leading the organisation.

Our role as a Board is to set a long-term course for Jewish Care so that future generations will be served by a strong, professional and sustainable organisation. The directions we have set will have long-term benefits for the Victorian Jewish community. Our Board is skilled, hardworking and committed to support our community with high quality programs and facilities. They go above and beyond to lead Jewish Care and will continue to take our organisation forward. My thanks to all Directors, past and present, for your support of me as President and your work for our community.

We are fortunate to have skilled staff and volunteers who are committed to providing quality services to vulnerable and disadvantaged members of our community. I would like to thank our staff and volunteers for their hard work and contribution to Jewish Care.

There is much work to do. Our community's needs and expectations are always changing. The focus on personcentred care will continue, new issues will emerge from current Royal Commissions, and financial sustainability will continue to be challenging. Jewish Care must be at the forefront of reform.

One of my first duties as President was to preside over our 165th anniversary celebration, a significant function held at The Hotel Windsor in 2013, with the Premier, community leaders, our supporters and friends. As one of the oldest philanthropic organisations in Victoria, Jewish Care has a long history of supporting disadvantaged members of our community. In 1948, when my parents arrived in Melbourne as Holocaust survivors from Poland, it was Jewish Care who provided the assistance they needed.

I have been privileged to play a part in continuing this vital work and leading this organisation over the last seven years. I look forward to a wonderful future for Jewish Care and the community it serves.

CEO'S MESSAGE

Lord Rabbi Jonathan Sacks says, "The test of faith is whether I can make space for difference. Can I recognise G-d's image in someone who is not in my image, whose language, faith, ideals are different from mine? If I cannot, then I have made G-d in my image instead of allowing him to remake me in his."

We believe that a healthy, relevant, democratic community needs the diversity of all to be fully embraced and authentically engaged. Over the last 12 months, Jewish Care has continued to work constructively towards a just and equitable society, truly embracing and celebrating, diversity in all that we do. Ensuring all members of our community are positively included and can equally access all benefits through employment, volunteering and service provision.

In November 2018, we celebrated our 170th birthday - 170 years of providing much needed services and supports to thousands of people each year. Fittingly, this milestone event was celebrated at Quat Quatta in Ripponlea, with past Presidents. Life Governors, volunteers. donors and staff. We heard from several amazing people who shared their heartfelt reflections about Jewish Care and what the organisation has meant to them and their families, and why Jewish Care is so vitally important to the health and wellbeing of the Victorian Jewish community.

I often wonder how our visionaries would have viewed the challenges we are faced with today. Was it any less challenging, or just different, 170 years ago?

The past year has been volatile to say the least, both internationally and domestically. In the human services space, we have three Royal Commissions underway in aged care, disability and mental health. We continue to closely monitor and contribute to these reviews that will hopefully serve to improve quality outcomes for the people we support. Creating clarity of purpose in a climate of unprecedented change is critically important if we are to realise our objectives and remain on course with our transformational change agenda.

As this report will show, 2018/19 was another year full of projects, achievements and milestones that have contributed to achieving our vision of building and supporting a healthy, resilient and inclusive Jewish community.

I would like to make note of just some of the key highlights of the year. Jewish Care:

- Supported 399 Elders in Residential Aged Care; 4931 clients across Active Living Services, Disability and I&FS, and 244 job
- Operationally made an overall EBITDA surplus of \$701,000 and surplus of \$11.26 million with the sale of our Northcote Avenue property;
- Held a very successful celebration to mark the mid-way point of construction of The Hannah & Daryl Cohen Family Building in March 2019 with the Australian Treasurer, The Hon Josh Frydenberg, the Cohen family and other Major Donors in attendance. The \$93 million building is due for completion in February 2020;
- Signed two contracts and commenced works for The Anne & Eric Smorgon Active Living Centre and our 120-bed Senior Living Community in Carnegie;
- Completed a significant \$2.9 million refurbishment of 36 transitional housing units in St Kilda East:
- Restructured Active Living Services to provide a more streamlined service response to our community;
- · Negotiated further growth in our Commonwealth Home Support Program (CHSP) funding to expand our Healthy Ageing and Community-based services;
- Successfully underwent accreditation at Gary Smorgon House under the new regime of the Aged Care Quality & Safety Commission;
- Demonstrated outstanding achievements in Person-Centred Active Support in our Supported Accommodation through our LaTrobe University evaluation;



- Secured grants for family violence community education and awareness efforts, and employment program initiatives;
- Re-signed our MOU with Maccabi supporting the All Abilities Program that provides much-needed recreational opportunities for people with disability;
- Actively participated in the current Aged Care Royal Commission including hosting a visit by the Commissioner, Richard Tracey in March 2019;
- Diligently completed a migration from our servers to a cloud environment ensuring business continuity and data sovereignty;
- Conducted a very successful Ethos Retreat for 40 leaders across the organisation;
- Graduated 12-job ready, non-executive Directors through our Yesod Board Foundation Program;
- Held another very successful Staff and Volunteers Service & Excellence Awards evening where two staff members were given the opportunity to attend the 2019 March of The Living program;
- Attended The Claims Conference Convention in Atlanta (It is the first time in 10 years that this conference has been held) as well as the conference of the Network of Jewish Human Service Agencies;
- Completed a beautiful hardcover coffee table book to commemorate our 170th Anniversary;
- Achieved a further three years of Safeguarding Children Accreditation through the Australian Childhood Foundation;

- Was formally accepted into the National Redress Scheme to provide support to people who have experienced sexual abuse in an institutional setting as a child in February 2019;
- Adopted a position statement on Voluntary Assisted Dying which came into existence mid-June 2019;
- · Continued our progress towards Rainbow Tick Accreditation;
- Proudly participated in the annual In One Voice community festival; and lastly
- Concluded a very successful Annual Appeal campaign resulting in \$3.245 million raised through a combination of hosted dinners and marquee events.

I would like to acknowledge our Board and the respective subcommittees for their ongoing stewardship, commitment and guidance over the last 12 months, and thank them for the trust they place in me every day. I would like to especially acknowledge our outgoing President Mike Debinski, and Treasurer Rohan Filer, for their significant contribution over many years. Both have held critically important roles and have provided the stability and cohesion needed during a period of significant growth and change. I would like to personally thank Mike for his wonderful commitment over seven years as President. Together, we have spent a large amount of time debating and discussing all things Jewish Care, and I shall miss this working relationship.

I would also like to recognise the terrific work of our very capable and hard-working leaders across the organisation. With a strong sense of purpose and unity, our leaders continue to work collaboratively to help build and support a healthy, resilient and inclusive Jewish community. The 2019 Ethos Retreat was a key highlight on the calendar, where we all got to share and learn more about diversity of identity within the Jewish community. Together, we have traversed some challenging terrain over the last 12 months and the next 12 months will be just as challenging with the exciting opening of our three new state-of-the-art facilities amounting to an investment of over \$139 million.

To our wonderful staff and volunteers, you continue to inspire me. I sincerely thank you for your ongoing commitment to the provision of dignified, quality care and support, and the unconditional regard you demonstrate for our community each day. The way you approach your work gives hope and confidence to the individuals and families we support.

I would also like to extend my deepest appreciation to our donors, organising committees, corporate sponsors and communal lay leaders. It has been wonderful to see that despite the 'Growing. For Our Community' Capital Campaign running in parallel with our Annual Appeal over the last 5 years, you have continued to generously support our vital social justice programs.

The Capital Campaign has now exceeded \$30 million in donations, making it the largest fundraising drive in our 170-year history. I would like to acknowledge the leadership of Alan Schwartz AM (Patron), Susie Ivany OAM and Lisa Kennett (Co-Chairs of the Capital Campaign committee) and Mark Joel (General Manager Communityadd a close bracket) for their extraordinary leadership during this multi-year campaign. To all our Major Donors, thank you for demonstrating such wonderful philanthropic leadership. May your generosity of

spirit inspire others to be part of this once-in-a-generation opportunity to change the face of our services with the delivery of six much needed projects in 10 years.

In closing, I would like to acknowledge and pay tribute to our grand history and all of those who have paved the way for Jewish Care to continue serving the community today. From humble beginnings in 1848, we have grown to be one of Australia's oldest for-purpose organisations and the largest service provider to the Jewish community. On behalf of Jewish Care, I want to thank and honour all those who have given of themselves in time, spirit and generosity for the betterment of others in our community throughout the generations.

The year ahead will not be without its challenges, but I am buoyed with confidence that our diversity and togetherness, united by a strong sense of purpose, strengthens us to continue our journey of enriching lives.

CREATING OPPORTUNITIES

Our Individual & Family Support Services cater for children, young adults and families to achieve positive outcomes by alleviating the conditions of poverty and disadvantage in our community.

Jewish Care's purpose for more than 170 years has been to deliver excellent care and supports to the Jewish community to enable individuals and families to live healthier, connected and fulfilled lives. Over the past 12 months, our Individual & Family Support Services team have assisted hundreds of people to create better outcomes for themselves by facilitating access to housing, employment, financial aid and support, disability services and youth mentoring support.

In 2018/19, the team continued to solidify their integrated support system to meet the diverse needs and interests of clients, and collaborated across their program areas to create more opportunities for clients and staff.

Many partnerships were established with community organisations and committees to advance our work towards educating and creating awareness on matters including family violence, gambling, mental health, youth networking, elder abuse prevention and integrated family services. Some of this work secured grants to support people adversely impacted by family violence and unemployment.

The Front Door team was able to help more callers this year, connecting individuals with My Aged Care and Jewish Care's support services including Empower Interest Free Loans, service coordination, financial counselling, housing support and disability support.

SERVICE COORDINATION

The Service Coordination team responded to 300 referrals, linking community members with internally and externally driven programs relating to family violence, housing and mental health.

With clients displaying multiple health conditions, from substance abuse and family breakdowns to physical health problems, the team was required to double their efforts during the year. This required additional assessments, intensive support, liaison and consultation with multiple external and internal support services, and more creative and flexible approaches to meet the varying needs of clients.

HOUSING SUPPORT

Jewish Care continued to address the needs of those most vulnerable in the community by offering them suitable housing options within Jewish Care and partner agency properties. A variety of issues were seen impacting clients' ability to access independent housing, stemming from serious mental health issues, physical health and mobility issues, comorbidity, hoarding, relationship breakdowns and unemployment.

During the year, 139 individuals comprising 60 women, 46 men and 33 children were housed in Jewish Care and partner agency properties.

With the transition of property and tenancy management of The Manders Villas from Disability Services to I&FS, significant activities were undertaken to improve the process and amenities at The Manders Villas. These included signing of new residential leases, introductory meetings for new tenants, meetings with family members and upgrades to furniture and appliances.

HEALTHY COMMUNITIES

In 2018, the Healthy Communities team experienced further consolidation of the team with a focus on community education, raising awareness and building capacity in the areas of mental health promotion, family violence education and financial literacy.

Mental Health Promotion targeted activities around enhancing knowledge of mental health issues, building positive mental wellbeing in the community and increasing knowledge and responsiveness of Jewish Care staff. The team also engaged with Community Security Group and Australasian Zionist Youth Council leaders in organising presentations, resource support and secondary consultations on positive mental health.

Family Violence Resource activities focused on building capacity in community members to recognise and respond to family violence, and to raise awareness on gender inequality with a particular focus on engaging men, boys and the Orthodox community. Some of the key highlights were activities organised in support of International Day for the Elimination of Violence Against Women and International Women's Day; family violence training for kallah teachers and mikvah attendants; presentation to Victoria Police family violence specialist staff, and collaborating with Monash Health and Bouverie Centre to host Elder Abuse training for Jewish Care staff and community members.

YOUTH MENTORING

The Young Achievers and Youth Aspire Programs continued to attract new participants to the program, reaching its full capacity of 30 and 10 young people, respectively. The year ended with each young person receiving a certificate of participation and educational scholarships.

The Young Achievers Program engaged participants in a range of activities including a two-day camp to Blairgowrie and evening and weekend activities to keep them motivated and connected to work, study and the community.

Youth Aspire focused on the provision of mentoring young people who were at greater risk of having personal or family issues impacting their ability to cope with school or vocational training and friendships. All participants viewed maintaining

and cementing positive engagement with their schools and reflecting on future aspirations as important elements of their mentor relationship.

As further development, past Young Achievers were invited and integrated back into the program as mentors, creating opportunities to contribute to the program. Mentor training, which was previously outsourced, was absorbed back into the program providing a seamless process to mentors with mentees.

EMPOWER INTEREST FREE LOANS

The most popular loans, in terms of number and value, were car loans, debt consolidation loans and business loans. Improvements were made within the program to introduce a new online loans management system and to limit the use of paper for reports, storage and documentation.

In addition to loan disbursement, 23 tertiary scholarships were awarded to those facing financial hardships in the community.

FINANCIAL COUNSELLING

Over 258 individuals and couples presenting different circumstances, from business failures to lives being chronically impacted due to financial strain, were assisted with financial counselling. The most common reasons to seek financial counselling were inability to pay loans, credit card debt, rental/mortgage stress and inability to pay utility bills.

EMPLOYMENT CENTRE

The Employment Centre developed a better structure to support job seekers with a disability or disadvantage to connect with professional employment consultants and volunteer services. This has yielded faster outcomes for clients and better resource allocation for Jewish Care.

Key highlights were the implementation of an employment pathway for job seeker intervention, establishment of a partnership with Uniting Disability Employment Services and successful completion of the Jobs Victoria contract. Additionally, the team was able to launch two new Learn Local training programs for women and Elders, and increase their involvement with job seekers supported by the National Disability Insurance Scheme.

TAKING A LEAD IN WELLBEING

Jewish Care is committed to ensuring the needs of our Elders are met in the fullest and best possible way so that they can live their lives with the dignity they deserve.

Throughout the year, our Elders were connected to caring and vibrant communities, making a positive difference to their daily lives. Some of our programs facilitated socialising with those from different generations and backgrounds, benefitting everyone involved. Elders shared their knowledge and experience, and in return, have learnt to use technology including social media, virtual reality experiences and improve their computer literacy. Regular outings and concerts that were held outside and on Jewish Care premises were also refreshing opportunities to improve on their general wellbeing.

Jewish Care hosted politicians for community consultation with Elders at our St Kilda Road site in October 2018 and April 2019, prior to Federal and State elections. The consultations were wide-ranging and included discussion on the diverse needs of older Victorians, including health and wellbeing, living in the community, transport, information technology, housing, accessing information and economic considerations as people age. Presentations were made by Mr Josh Burns (ALP), Ms Steph Hodgins-May (The Greens), Ms Kate Ashmor (Liberal Party) for the Federal election and Ms Sorina Grasso (ALP), Ms Nina Taylor (ALP), Ms Margaret Fitzherbert (Liberal Party) and Mr David Southwick (Liberal Party) for the State election.

We continued to assist families and clients to access government support services through My Aged Care and Claims Conference funding. We have seen a steady increase in the number of people enjoying these programs and utilising Jewish Care's services as a result of our intervention.

Active Living Services leads the way in the provision of socialisation and recreational activities for older people living within the community. With the team's new structure in place, over 700 clients were supported with a range of activities creating stimulating environments for ongoing engagement with the community.

By addressing carers' needs as well, Active Living Services

remained a focal point for all those involved in providing care for a spouse or a parent, including those with special requirements and living with dementia.

The team also introduced the Blue Star Bonanza to build connection and capacity within the mobile Blue Star workforce. Staff were able to connect with each other to receive essential education and training, and be recognised for the key role they play in supporting Elders to continue an active life, living in their own homes

With accreditations being the ultimate measure assessing the quality of care and services provided to our Elders, Jewish Care recorded multiple successes, passing all unannounced accreditation visits. All residential homes and our in-home services have achieved excellent results in this year's unannounced spot checks, and remind us of our commitment to all-round excellence in services and care provided to our clients.

We also provided Elders and their families opportunities to collaborate with us in the food preparation and delivery process, empowering them to make real choices that directly impacts their general wellbeing.

LIVE THE LIFE YOU ASPIRE

Disability Services continued to support people with disability to develop skills and increase their capacity to live as independently as possible.

PLANNING AND CARER SUPPORT

People with disability, their families and community members were assisted to access supports and information throughout the year, specifically for participants transitioning to the National Disability Insurance Scheme (NDIS) on topics including the NDIS, Estate Planning and Education and Health.

Relationships were established with a variety of professional service providers to refer more clients to their services and be secure in the fact that our clients will receive quality services.

DAILY LIVING SUPPORTS

The Daily Living Supports team offered an array of in-home and community access supports catering for clients' needs

Attending events, engaging in healthy activities, enjoying companionship and maintaining relationships with friends and family were major focuses for developing an independent and meaningful life. Many skill development training sessions were also organised around areas including managing transport, money and technology, enabling clients to plan their daily activities by themselves.

As a trusted advisor, the Daily Living Supports team continued to educate clients who were on older funding models with information, advice and referrals, preparing them for the NDIS. This support has at times been in conjunction with the National Disability Insurance Agency to connect clients to the Agency and with Service Coordination.

RESPITE SERVICES

The Coppel & Piekarski Family Disability Respite Centre has seen a growth in community based activities making the Centre one of the best options for short term accommodation.

The team was able to successfully transition group programs such as the Saturday Night Fever Disco and Holiday Arts, which were originally organised by City of Port Phillip. After many years of being run by the Council, our committed staff and volunteers have worked hard to grow the popularity of these events. The Saturday Night Fever Disco continues to be one of the most enjoyable events for people with disability, attracting more than 100 people each time.

The demand for children's group activities have doubled during the year with assistance from City of Port Phillip, who have helped to transport children via school buses, giving them direct access to activities with little disruption to their routines.

We were also able to reduce the admission time at The Coppel & Piekarski Family Disability Respite Centre, as a result of our improved relationships with schools and other service providers.

SUPPORTED ACCOMMODATION

The team supported clients with disability residing in a shared home to achieve their personal goals by building capacity and self-determination.

We continued our major transformation, viewing our Supported Accommodation Services as homes, supporting 18 individuals to live according to their own choices and emerging life interests.

This included identifying personal goals, enhancing the quality of support delivery, widening the circle of engagement with cultural life and building high quality communication.

Major internal renovations were also completed at each home, facilitating greater engagement and utilisation of skills among clients.

CARING FOR STAFF AND VOLUNTEERS

Our staff and volunteers are pivotal to the ongoing success of Jewish Care and we are committed to investing in them through training and development, education and wellbeing initiatives.

Our multifaceted training calendar included professional learning and development programs aimed at supporting staff and management in meeting their specific needs and requirements. Over the past 12 months, we rolled out a range of programs aimed at developing competencies and enhancing knowledge around our service provision, including development days, ethos days, learning lunches, Grow Zone programs and leadership training programs.

Potentialife was rolled out in 2018 to build strong leadership capabilities in our leaders. Attended by over 40 people, the training program was found to be relevant and useful in assessing our staff and their expectations, preparing for future demands and aligning with the overall strategy of the organisation.

The Yesod Board Foundation Program continued to produce job ready Board directors with a member already taking up a Board position in the not-for-profit sector. The program, now in its fourth year, has immersed over 50 next generation participants in best practice principles of governance.

Ethos days, learning lunches and development days enabled staff to gain a deeper understanding of Jewish life and culture, and be culturally competent to meet the needs of our Elders and clients, in turn, helping to improve their health and wellbeing.

The 2018 Staff and Volunteers Service & Excellence Awards honoured staff and volunteers who have given of their time to Jewish Care, and others, for their exemplary work and achievements. The two major awards, Samuel H Harris and Volunteer of the Year, were presented to Russell Griffiths and Ian Fayman. The opportunity to represent Jewish Care

at the 2019 International March of The Living program was presented to Fross Driscoll and Samuel Murray. They joined thousands of others from around the world in a three kilometre walk from Auschwitz to Birkenau, and learned more about the history of the Holocaust.

Other staff and volunteers including Gwenneth Hill, Sorin Ronea, Dr John Serry and Jeffrey Appel OAM, were recognised for completing 30 and 35 years of significant service to Jewish Care.

We continued our successful collaborations with other training providers to assist job seekers in securing job placements by completing their training with RMIT, Holmesglen, Southern Cross Education Institute, Selmar and Australian Learning Group, and provided students with work experience opportunities.

VOLUNTEER SUPPORT

The Volunteer Department was busy engaging volunteers in orientation programs around values, policies and support roles, following the transition from People and Culture to the Community Department.

Improvements were made within the program to offer a more rewarding experience to volunteers and others requiring volunteer support. These included meeting service area requests for volunteers in less than 24 hours, improving two-way communications, improved information sharing and recognising and rewarding volunteers more often. Nominations were submitted to several community and council awards programs recognising volunteers, including Howard Silman, Anne Fajerman and Henri Korn.

Other initiatives introduced over the year included Feast with Friends for disability clients, computer courses at Gary Smorgon House, Mums and Bubs play group for Elders and distributing food prepared by Our Village Kitchen to community members in need.

Jewish Care remained true to its vision by offering a spiritual home for Elders, clients and their families through the delivery of a range of pastoral, rabbinical, kashrut, and cultural services contributing to their emotional, physical and spiritual wellbeing.

Our Jewish Life team facilitated new and old experiences to create a welcoming environment for everyone across our residential and disability support homes. Elders, clients and staff were involved in a wide range of activities, engaging and helping one another during the festival celebrations from Rosh Hashanah and Succot to Chanukah.

Pastoral care and rabbinical services continued to provide comfort and spiritual guidance to Elders and clients during their difficult times, and kashrut services ensured healthy, nutritional and quality kosher food for everyone from Elders to visitors.

Other activities included a Lag B'Omer parade; challah and Matzah baking; Mitzvah days with families; Pesach seders; and a special Bar Mitzvah organised for Israel Olshina, a 94-year old client with complex medical conditions who was deprived of his Bar Mitzvah at the age of 13 years, during the Holocaust.

PROPELLING US FORWARD

Jewish Care continued to set benchmarks in community, aged care and disability spaces by providing excellent outcomes for our clients.

Quality has always been integral to our operation and in 2018/19, significant investments were made in the areas of systems, procedures and standards. The Quality and Innovation department was also abuzz with an unprecedented number of activities, programs and audits in response to the changing landscape of aged care and disability services.

Jewish Care continued to dedicate resources and expertise across the Royal Commission into Aged Care Quality and Safety; the Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability and the Victorian Royal Commission into Mental Health Services, in anticipation of better outcomes of people requiring supports.

Our collaborations with external research partners enabled investigations into a range of questions associated with our clients, services, cultural and social expectations and care models. We also commenced several studies with La Trobe University on Active Support and Practice Leadership in Disability Services and Evaluation of Hand-in-Hand™. Our Hand-in-Hand™ model of support has been pivotal in offering a rich and rewarding experience to our Elders, enabling them to maintain skills, interests and relationships.

Benchmarks were set up for aged care, in-home care and disability services, establishing effective procedures and systems to support organisational strategic direction. In addition, extensive work into current activities, work processes, practice standards and governance framework was undertaken to ensure that we not only meet, but exceed the expected standards when the new Aged Care Standards and National Disability Insurance Scheme practice standards are introduced.

Jewish Care reported excellent outcomes against all 16 accreditations and unannounced spot-checks throughout the year. These results were, in a sense, symbolic showcasing our efforts in supporting our clients in ways that they like to be supported through engagement, culture, lifestyles, food and towards providing dignified care.

Rainbow Tick Accreditation work continued with consultations with members of the LGBTI+ Jewish community and their allies, and an education program dedicated to staff and volunteers on inclusion - Living our Values. The contributions made by this group were critical to our work in building inclusive practices across the organisation.

Our participation in the annual Pride March in St Kilda was another opportunity to showcase our commitment to supporting the LGBTI+ community.



As part of Jewish Care's strategic commitments, the Information Technology strategy addressed system deficiencies and implemented new technologies and infrastructure to provide efficient and effective processes that would enable quality service provision and accountability.

Cloud migration assisted in reducing ongoing costs, increasing disaster recovery capabilities and times, improved remote access, decreased the risk involved in future migrations and reduced management of hardware and software. Functional improvements were made to Procura, our client management system, to offer a better client experience and engagement through the delivery of improved mobility, rostering and clients records.

We continued to provide leadership and advocacy to critically important issues and shared valuable insights by making presentations and speeches, both in Australia and overseas. Mike Debinski and Bill Appleby's presentation on dementia care for Holocaust survivors in Atlanta was one key highlight that received overwhelmingly positive feedback from industry leaders worldwide.





PLANNING FOR A BETTER TOMORROW

The "Growing. For Our Community." Capital Campaign was launched with the aim of revolutionising our services and supports to the Jewish community through the delivery of six state-of-theart projects in Victoria.

Thanks to the generosity of our donors and supporters, Jewish Care has received more than \$30 million in capital pledges since 2014. Charles Holckner OAM and his family's \$5 million pledge to Jewish Care will assist with the development of the entire precinct, including The Hannah & Daryl Cohen Family Building and St Kilda Road Stage 2 development, and to be known as The Holckner Family Senior Living & Community Precinct.

Their \$5 million pledge becomes the equal-largest donation in the history of the Victorian Jewish community, equalled by the gift made by Hannah Cohen and family in 2016.

More than \$11 million was raised this year from a stream of fundraising events to meet the ongoing costs of a broad range of services to the community and allow for forward planning.

In planning for the future, Jewish Care was able to complete the refurbishment of 36 community housing units in August 2018 and three more projects commenced construction with an anticipated completion in 2020; The Hannah & Daryl Cohen Family Building, The Anne & Eric Smorgon Active Living Centre and Carnergie Senior Living Precinct.

THE HANNAH & DARYL COHEN FAMILY BUILDING

A special ceremony was held in March 2019 to mark the halfway point in construction of The Hannah & Daryl Cohen Family Building with the Treasurer, The Hon. Josh Frydenberg, as the guest speaker. The Cohen family was recognised and honoured for their valuable contribution towards this building. The milestone event was attended by others including donors, senators, MPs, Board members and Elders who were significant in seeing this project come to life.

The Hannah & Daryl Cohen Family Building will feature 156 beds across seven levels, two levels of community services and landscaped terraces and balconies.

Internal works commenced earlier this year with the building reaching its full height of nine floors. Watpac Construction is currently focusing on power installation, basement kitchen, tiling, window installation, and joinery installation, preparing for completion in early 2020.

COMMUNITY HOUSING, EAST ST KILDA

The Fulton Street Community Housing refurbishment project has brought new life to old infrastructure by revitalising and refreshing external and internal aspects of the building. Thirty-six units were completely refurbished, creating more space and comfort internally, combined with the repair and maintenance work of gutters, downpipes, external fencing and landscaping.

An amendment to the existing town planning permit of 33 units was lodged in 2018 in preparation for Stage 2 of the St Kilda East Community Housing project. This has been the outcome of a detailed review of the current land holding with the new permit seeking to extend the development to 53 units.

CARNEGIE SENIOR LIVING PRECINCT

ARC3 was awarded the contract to develop the 120-bed Senior Living Precinct in Carnegie.

As of June 2019, basement excavations, wall panels and lift shaft installations have all been completed, making way for inground services to advance. Construction of this project is due to be completed in September 2020.

ANNE & ERIC SMORGON ACTIVE LIVING CENTRE

With the signing of a building contract between Jewish Care and FourSquare, construction commenced earlier this year on The Anne & Eric Smorgon Active Living Centre.

A ground-breaking event was held with members of the Jack and Robert Smorgon Families Foundation with Jack Smorgon AO, Val Smorgon OBE, Vicki Smorgon and other family members to turn the first sod of earth at the site.

Due for completion in April 2020, the \$7.15 million Anne & Eric Smorgon Active Living Centre will support healthy ageing for Elders living at Gary Smorgon House and independently in the local community, providing a range of allied health services, consulting rooms and a gymnasium.

Jewish Care also received the support of other committees, such as Friends of Montefiore and Generations of Women, by raising funds for our causes. Circle of Care events continued to acknowledge donors who have agreed to leave a gift in their will to Jewish Care. Bequestors and next of kin were also honoured for making their families an important part of the decision to support Jewish Care.

The 2019 Annual Appeal continued to exceed expectations by raising over \$3.2 million towards funding a broad range of services and programs for those in need.

HONOURING OUR **BENEFACTORS**

JENNY BURNS

Born in Ruzan. Northeastern Poland. in 1930, Jenny (Genia) nee Mrocki escaped the German army with her mother and siblings, surviving labour camps in Siberia and the Ukraine. After the war. she immigrated to Melbourne where she met and married Phillip Birnbaum. The couple raised two children, Faye and Colin, and

PAULA AND LEON FLINKIER

Life partners Leon and Paula Flinkier immigrated to Australia from Poland with their

SYLVIA GELMAN AM MBE

A communal leader in education and women's rights for over six decades. Svlvia was Headmistress of Mount Scopus Memorial College and served in various roles for the National and International Councils of Jewish Women of Australia. She was awarded an MBE. a Member of the Order

of Australia. the JCCV Sir John Monash Award and was included in the Victorian Honour Roll of Women. Her bequest honours Manuel Gelman, her life partner for 43 years, and her parents Maurice and Elizabeth Benn and sister Marie Victoria Wittner.

ANNI MARGARETHA INWALD

Anni Margaretha Inwald was born in Germany in 1934 to Margaretha and Ladislaus Wolf Inwald. Persecuted because of his



Jewish grandmother, Wolf was interned in Buchenwald in 1938 for several months. The family immigrated to Australia in 1939 where Wolf worked as an electrical engineer but continued to suffer from his previous mistreatment, and passed away when Anni was only 13. A kind and giving person who lived a quiet life, Anni's bequest is in honour of her father and the support given to him by Jewish Care.

CHARLOTTE KLEIN

Charlotte was born in Berlin in 1916, immigrating to Melbourne with her husband Leopold in 1949. Purchasing a chicken farm in Springvale, they delivered eggs to customers in St Kilda, such as the famous Acland Street restaurant, Scheherazade. Later, the couple subdivided the farm and founded Elka

Constructions which Charlotte continued to oversee after Leopold's passing in 1976. She celebrated her 100th birthday in 2016.




ISOBEL NEWBERG

Isobel was the eldest child of Herman and Minnie Woolf, sister to Ruth, Phil and Robert. Growing up in Elwood, she was popular and possessed a keen sense of humour. She was also regarded as a promising pianist. Together with her husband Len, Isobel raised three boys and maintained a

lifelong interest in the arts, particularly in music and painting. She remained forever loyal to her faith and was a generous supporter of various causes, of which Jewish Care was a favourite.

EVA & DAVID NISSEN

Originally from Poland, Eva and David survived the war years in Europe, losing many family



Holocaust. They met in Melbourne after the war and raised a daughter, Jeannette.

David was a businessman, managing his knitwear stores for over 40 years. Eva supported him in the business while also pursuing her passion as an artist. They shared a love of music and of nature, although their greatest joy came from being grandparents to their adored grandsons, Ryan and Troy.

Dedicated supporters of Jewish Care, they recognised the important work undertaken by the organisation in all aspects of community life.



TIBOR PAP

Tibor was born in Hungary in 1927 to Mano and Lili Pap, immigrating before the outbreak of WWII to then Palestine and eventually Melbourne,

where he secured employment at Torino Knitwear. Tibor was dedicated to the care of his mother until her passing in 1985. Taking up residency at Montefiore Homes, Tibor appreciated the opportunity to converse in his mother tongue of Magyar during weekly visits with one of Jewish Care's volunteers. Tibor's bequest will help to ensure the ongoing provision of care for members of the Jewish community in need.

MAGDALENA AND EDWARD RIEDER

Immigrating to Melbourne after WWII, Holocaust survivors Magdalena and Edward were known for their charitable nature Torah observant and members of the Adass Israel Shule. they were of modest means but generously supported



all Jewish institutions, especially schools, shules and the needy. Exemplary in their dealings with others and liked and respected by all, their bequest supports the ongoing delivery of care to those in need.



DAVID ZYK

Descended from a long line of Gerer Chassidim, Holocaust survivor David Zvk survived the Warsaw Ghetto and a number of concentration and work camps. His parents Vawlf and Golde, siblings Hershel, Pinchus, Gitl


and Rivka and his entire extended family of hundreds of relatives were murdered, leaving David on his own as a young teenager. After the war he was brought out to Australia to help build railroads, and eventually settled in Melbourne. David continued to live independently in his later years, supported by Jewish Care.

TREASURER'S REPORT

On behalf of the Chief Executive Officer and Board of Management, I am pleased to present a summary of Jewish Care (Victoria) Inc financial results for the 12-month period 1 July 2018 to 30 June 2019 (FY 2019). Our financial statements have been prepared in accordance with Australian Accounting Standards.





It was a fulfilling year with a number of construction projects underway which are all well-funded by a combination of funding from capital donations, debt facility and refundable accommodation deposits obtained from our generous community, ANZ Bank and Elders, respectively. It was a year of investments in capital development, leveraging off the assets in the organisation whilst strengthening the Balance Sheet. We continued to obtain the funding support from the State and Federal Governments for some of our key services that we provided to our deserving Elders and vulnerable people within our community. We also provided our ongoing support to the Holocaust survivors of our community with financial assistance from the Material Claims Conference. The NDIS rollout plan from the State to Federal funding is coming to an end and we have managed this change quite smoothly and provided high quality disability support to individuals and families across a range of services.

Jewish Care has had ongoing support from the Jewish community for a long period of time with good responses all round in bequests, capital and annual appeals as shown in Figure 1. We are pleased to announce that we have achieved the \$30 million target in capital appeals and are confident that the Capital Campaign pledges will continue to grow as The Hannah & Daryl Cohen Family Building, Carnegie Senior Living Community and The Anne and Eric Smorgon Active Living Centre in Caulfield, near completion.

KEY HIGHLIGHTS

Some of the key financial highlights for the year were as follows:

- Construction commenced at 1 Wahgoo Road, Carnegie for a new 120 bed Senior Living and Community Precinct.
- Construction commenced at the new Anne & Eric Smorgon
 Active Living Centre in Caulfield abutting the existing
 Gary Smorgon House which will also include extensive
 refurbishment works to the second floor amenities.
- Completion of the refurbishment of our 36 Community Housing Units located at our St Kilda East site in Fulton Street.
- Received \$5.024 million from capital appeal fundraising in addition to annual appeals for the year of \$3.256 million. The donors in our community continue to support the strategic vision and the major projects that Jewish Care Victoria is embarking on.
- Our bank, ANZ, has continued to provide support through the provision of debt funding for the two substantial capital development works being undertaken at St Kilda Road and Wahgoo Road in Carnegie.
- Continued financial funding received from the Material Claims Conference towards providing critical care and support services to our Holocaust Survivors.
- Extensive support towards social justice programs particularly towards Individual and Family Support and Disability Support Services.
- Investment Funds, separated into two portfolios (one relating to refundable accommodation deposits and the other relating to bequests and capital appeal funds received) continue to deliver returns in a volatile market. Funds were drawn down during the year as required for construction costs towards the 156 bed Senior Living Precinct capital project at 619 St Kilda Road, Windsor, the 120 bed Senior Living Precinct capital project at 1 Wahgoo Road, Carnegie and The Anne & Eric Smorgon Active Living Centre, Caulfield.

SUMMARY OF KEY FINANCIAL RESULTS

Jewish Care delivered an \$11.267 million surplus from operations for the year. Included in the surplus is the one-off recognition of gain on sale of the Northcote Avenue land of \$5.443 million. This reflects the range of diverse support services needed by our community, including unfunded social justice programs which are provided by Jewish Care, with only a marginal revenue base and which rely on community support to fund.

In FY2019, Jewish Care continued to invest in the welfare of vulnerable members of our community. The social justice programs in Individual and Family Support Services and Disability Services amounted to \$2.421 million after netting support through Government funding.

Overall expenditures have been well managed, with continued savings derived as a result of our repairs and maintenance function being carried out by an in-house team.

Jewish Care invested further in its technological services by migrating all its applications and servers onto a Microsoft Cloud platform which will provide improved reliable management and enhanced service delivery channels.

Salaries and wages continue to be the largest expenditure incurred by Jewish Care at \$44.234 million, 65% of the total expenditure (FY 2018 \$45.59m, 65%), with the organisation employing 770 employees as at 30 June 2019.

There was a net increment in the total value of the land and buildings held at FY 2019 as shown in the Reserves and no impairment had been required in the Statement of Financial Position for the year.

In conclusion, I would like to thank the members of the Jewish Care Board, Finance and Audit Subcommittee and the Executive of Jewish Care for their ongoing commitment in supporting and enriching the lives of the Jewish community. As the developments in Windsor, Carnegie and Caulfield near completion in the coming year, we can be assured that the infrastructure to support best practice services for the Jewish community for decades to come, will be in place.


