# 15 STRATEGIC PRIORITIES

Develop a long term sustainable Jewish Life Program across all Jewish Care programs that reflect the breadth and diversity of the Victorian Jewish community.
Support active ageing through the creation and operationalisation of 3 best practice senior living precincts, providing a suite of integrated services.
Review the potential growth of Residential Aged Care Services, following the commissioning of the St Kilda Road and Wahgoo Road developments.
Grow the breadth and depth of services for people living with a disability.
Ensure every person living with a disability in the Victorian Jewish community is appropriately supported through the assessment process with the National Disability Insurance Scheme (NDIS).
Develop measures for our social justice programs that can demonstrate clear and sustainable program and client outcomes.
Become a leader in individualised services through models of support that focus on rights, capacity, choice and self-determination of the client/Elder.
Enhance the Healthy Ageing Program in terms of service scope, viability and age attractiveness, and to reposition these services across the St Kilda Road Site and the new Anne & Eric Smorgon Active Living Centre.
Create an inclusive organisation that ensures all members of our diverse community are positively embraced and can equally access all benefits through employment, volunteering or service provision.
Develop a new Healthy Community Program to cultivate a safer, healthier and more inclusive community through communal education and awareness, and capacity building.
Transform Jewish Care's In-Home Services to successfully compete in the 5 Local Government Areas (LGA) of Stonnington, Port Phillip, Glen Eira, Bayside and Kingston, with an annual growth measured in package numbers and hours of in-home service.
Grow community housing through the development of more units at Jewish Care's Fulton Street site in St Kilda East.
Deliver on the \$30 million capital appeal strategy by December 2019.
Assess the feasibility of establishing a social enterprise that generates revenue to support unfunded social justice programs.
Continue to develop organisational leadership and culture that is aligned with Jewish Care's purpose, values and leadership behaviours.
